### PRIVILEGE OF THE FLOOR-FORMER FINCH PRUYN LANDS

Supervisor Geraghty opened discussion explaining the DEC and the Nature Conservancy are looking for a resolution of support for the purchase and land use of 2,019 acres of land in Warrensburg, which was formerly Finch Paper lands.

Maynard Baker, Schroon River Road – asked the Town Board if the tax base was going to change, to make sure that is in the resolution the tax base does not change so the tax payer has to pick it up and he would like to have something in the resolution in support of roads and trails open to ATV's at a speed not to exceed five miles an hour for the disabled American veteran and the handicapped. Mr. Baker told the Town Board a 6 million acre park had been closed to the disabled veterans and he would like to have this on record.

Supervisor Geraghty explained this property is off from Pucker Street and off from Harrington Hill and there are approximately five hunting camps on the property, the Town has been told the hunting camps will be left open. Supervisor Geraghty said for that to be added to the resolution of support, to leave the hunting camps open for 99 years.

Councilman Alexander told the board he knew what they were doing in the Opalescent area and the same thing had happened, the guys with the hunting camps figure they are good for five years and then gone, Finch Pruyn keeps logging rights for twenty years plus and they are all in hopes to keep the snowmobile trails open.
