Committee reports were given from the following: Beautification Committee, Economic Development, Highway, Historian, Museum, Parks and Rec., Landfill, Sewer, and Water.

DISCUSSION - TOWN OF THURMAN PROCEDURE

Councilperson Baker-Marcella told the Town Board she attended the Town of Thurman Town Board meeting on December 10, 2013 and she asked how they're using the orange bags policy they have had in place worked out and they told her it was a 100 percent success. Councilperson Baker-Marcella said they found a little bit of push back for the first couple of months but they found they were getting primarily their own residents garbage, they do not have people who are not residents bringing their garbage there and they felt they had better control of cash at that point. Councilperson Baker-Marcella said that at some point she would like to see if it is something the Town Board would like to do and see if it is something the landfill could handle. Councilperson Baker-Marcella said they sell packages of ten of each at the Town Hall and at the Landfill, it has worked out wonderfully well for them.

Supervisor Geraghty said that he thought it would be a good idea.

Councilperson Baker-Marcella said that Wendell asked what they do if someone shows up without it being in a bag and she said she told him they sell them a bag, they do not take anything unless it is in a bag.

COMMUNICATIONS

Supervisor Geraghty reported he had received the following communications:

1) A letter from DOT denying the request for a crosswalk on Richards Avenue.

2) The tax rate from Warren County.

3) A letter from Anna Busser Erik about the Chamber of Commerce.

DISCUSSION - CHAMBER OF COMMERCE

Supervisor Geraghty said that he had received a letter from Anna Busser Erik concerning how the funding is provided from the Town of Warrensburg to the Chamber of Commerce. Supervisor Geraghty said he was going to paraphrase, he was not going to read the whole letter but the Town Board each had a copy in their files. Supervisor Geraghty said there was concern about accepting members into the Chamber of Commerce, non-business members into the Chamber and because the Town does fund the organization perhaps the Town should have a meeting with the Chamber of Commerce Board of Directors. Supervisor Geraghty asked the Town Board if anyone else had a chance to review the letter, and, asked Anna if he was catching the jest of her letter.

Anna Busser Erik told the Town Board she wished to start the conversation about being involved in the Chamber and to just generate how the different groups in town can work together more.

Supervisor Geraghty said they would try to schedule a sit down with the Chamber of Commerce in the future, after the Holidays to address some of her concerns.
