Committee reports were given from the following: Beautification Committee, Economic Development, Highway, Lighting, Historian, Museum, Parks and Rec., Sewer, Water and Youth.

#### **COMMUNICATIONS:**

1) A letter was received from Sheriff York regarding the location of the Farmers Market on River Street stating he has been told it is dangerous for vehicles going in and out of the Market and stating he feels it is a very dangerous location, and asking that the Farmers Market be moved to a safer location, possibly the Pavilion on the Recreation Field.

#### **DISCUSSION - FARMERS MARKET**

Supervisor Geraghty opened discussion saying there would not be a debate on this letter, the letter has been placed on record that it is a situation the Town Board needs to address.

# DISCUSSION - SIGN FOR HOME OF FLOYD BENNETT

Supervisor Geraghty opened discussion explaining the sign for the entrance to the Town for the home of Floyd Bennett still needs to be addressed.

### **DISCUSSION - GROUND BREAKING FOR NEW HHHN BUILDING**

Supervisor Geraghty reported he attended the ground breaking for the new HHHN building this morning and said this will change the face of Main Street in the Town of Warrensburg for many years to come.

# **DISCUSSION - ADOPT TRANSFER STATION FEES**

Supervisor Geraghty opened discussion telling the Town Board that the new fee schedule was put together by the Landfill attendant, he is aware there are a few concerns with the Town Board.

Councilperson Reed said the Town currently accepts brush and leaves twice a year from the residents and she has a problem with charging the people who wish to clean up their properties and the Town is mulching the brush at the landfill so people can come and get the mulch for free. Councilperson Reed said the Town is going to charge people to dump it but allow them to take it for free, she would rather see that line item disappear.

Supervisor Geraghty suggested that the charges for leaves and brush be removed from the proposed fee schedule.

Councilperson Baker-Marcella said that she felt after checking with several other communities that the price list is in line with what other communities are getting so that is fine. Councilperson Baker-Marcella said she is in agreement with Joyce, the town should find a way to handle the leaves and brush at the landfill.

Supervisor Geraghty announced the Town will be developing something that will go out with the tax bills so that tax payers can take 4 tires at no cost or a mattress and box springs into the landfill, appliances and some other things. This would allow the residents an opportunity for an amnesty day.
