Councilperson Baker- Marcella opened discussion telling the Town Board in some of the constructive work they have been doing at the Chamber, they would like to send out some surveys perhaps to local businesses and to prior vendors to see what their responses are to the Garage Sale and any input they might have to improve it. Councilperson Baker- Marcella said that as Mrs. Smith had pointed out at one of their last meetings, it is within the top five of the largest events that are held in the County and they wish to keep it moving in that direction. Councilperson Baker-Marcella said the Chamber wanted to know if they could do the surveys through survey monkey, which the town pays a yearly fee to have survey monkey and there is no charge to have as many surveys as they want. Councilperson Baker-Marcella

said she wanted to know if the Town Board would allow the Chamber to use that, otherwise the Chamber will have to get their own subscription.

Supervisor Geraghty asked Attorney Radner to assist the Town Board with the SEORA information.

Attorney Radner told the Town Board the first thing that needed to be done was the resolution for SEQRA purposes, which is the environmental review. Attorney Radner said that she had spoken to Tom Suozzo of Cedarwood to ensure that there is nothing in this grant application that commits the town to go forward and spend the money on any project that would be a type 1 or an unlisted project, all that is going to happen at this point is the collection of information and data, it is not an invasive process. Attorney Radner told the Town Board she had prepared a resolution for them declaring this to be a SEQRA type 11 determination which says that because this is simply a collection of data not committing them to any process, this is not subject to further SEQRA.

DISCUSSION - HUDSON HEADWATERS HEALTH CENTER CONSTRUCTION

Supervisor Geraghty opened discussion reporting that the general contractor for Hudson Headwaters has walked off the job. Supervisor Geraghty said it was not just this job but several municipal jobs in the area; the project was bonded so there

are no real concerns other than it does slow the project down. Supervisor Geraghty said they expect to see another general contractor on the job within two weeks.

DISCUSSION - REQUESTS FOR GRANT

Councilperson Baker-Marcella opened discussion asking that Teresa Whalen have privilege of the floor for discussion with the Town Board regarding a grant application, and, said that she has a grant deadline.

Teresa Whalen- spoke to the Town Board requesting a resolution be passed in support of the pursuit of a grant funding for the preservation and rehabilitation of the Senior Center, the Miles Thomas House and a request to have a workshop meeting in March.

It was explained to Ms. Whalen that the Town is currently involved in so many different projects for numerous grants that the recommendation is to table the application at this time. Supervisor Geraghty said to receive a packet of information at 1:00 o' clock in the afternoon the day of the Board meeting and not have any time to study it is not the way he wished to do business. Supervisor Geraghty said if they are going to apply for money it is going to be done through the Town, he would like to have the Town Board delay this application for a year.

Councilperson Alexander asked Ms. Whalen who would pay for the match for this grant, the \$500.00. Ms. Whalen said that they have the \$500.00; they are not asking the Town for any money.

Councilperson Rounds asked Ms. Whalen if by applying for this grant the Town Board would be tying their hands for later on if they decided to put the property back on the tax roles. Ms. Whalen said not at all, this was just a conditions assessment.

Councilperson Reed asked Ms. Whalen if the Town gets a report this year and nothing can be done with the building for a year, would another report be required at that time.

Ms. Whalen said if the grant was approved in March of this year then the work would need to be done by the end of the year; we would not even have the report until the end of the year.

Discussion ensued. Supervisor Geraghty asked if the Board wished to bring the discussion to the floor.

Councilperson Baker-Marcella asked who the feasibility study would belong to.

Ms. Whalen said it would belong to the Town.

Supervisor Geraghty called for an end for discussion and called the question, and, asked if someone wished to make a motion.

The Town Attorney cautioned the Town Board that if they were going to make a motion to be very specific about what they were moving, the form resolution that they were given tonight did not match what was just described in the presentation.

Ms. Whalen asked in what way.

Attorney Radner told Ms. Whalen in huge ways, that the resolution said nothing about a feasibility study and who is paying the matching grants, the resolution has to say what she is saying.

No motion was made.
