#### **DISCUSSION - POSTAGE METER**

Councilperson Baker- Marcella opened discussion by saying she was sorry it was not on the agenda but she had just gotten this and showed two envelopes in her

hand. Councilperson Baker-Marcella said she had someone call her up and ask how many mailings the Town does a year, she told the caller she did not really know but when she quickly added up four water bills and four sewer bills and that she said she thought 11,000. Councilperson Baker-Marcella told the Town Board the caller said he had his tax bill in hand and said the Town had paid \$.46 to send it to him, he then asked her why Lake George sends their bill at \$.36. Councilperson Baker-Marcella said she did not know, there was a discussion a year ago and she told him she did not think they were using a different system. Councilperson Baker-Marcella said she wished to look at postage again, because a \$.10 letter difference times 11,000 is a \$1100.00 dollars and that is in fact that the two percent tax cap only allows them to go up \$20,000.00

Deputy Supervisor Alexander asked Town Clerk Combs how the service is used.

Town Clerk Combs said she would love to explain, if she could. Town Clerk Combs said she was not really prepared for the discussion tonight, she did not have the information with her. Town Clerk Combs said this had been discussed last year. Town Clerk Combs told the Town Board that while it is so that an envelope will be posted at \$.36, the actual bill that the town receives shows handling fees that brings the total cost of the postage to \$.46 per stamp. Town Clerk Combs said that as a savings to the Town of Warrensburg residents, and because it is time sensitive material, she choose to use the postage machine and do the postage in house. Town Clerk Combs explained that if a person has three or more parcels, all of their bills are pulled and mailed in one envelope for additional savings. Town Clerk Combs said it was always good to go to the source when information is needed and asked if she could meet after the meeting with Councilperson Baker-Marcella for further discussion and review.

# RETURN TO 2014 WARRENSBURG EMS PUBLIC HEARING Councilperson Baker-Marcella asked Mr. Emerson to tell the Town Board what has happened in the past year with the EMS.

Richard Emerson, Warrensburg EMS- spoke to the Town Board regarding the pending EMS contract, and the handling of the additional 57 calls in the Town of Thurman for the year 2013. Mr. Emerson told the Town Board Warrensburg EMS has purchased a new mini mod ambulance, it is a much smaller ambulance than what most of the towns are using right now but it saved them about \$60,000.00. Mr. Emerson told the Town Board the EMS used donations they received to help purchase power stretchers, and, they have gone to electronic billing. Mr. Emerson said they have also purchased all new I Pads so every thing is all electronic and ready to go. Mr. Emerson told the Town Board that Warrensburg EMS has applied for a grant for Life Pack Monitors, the cardiac monitors that the EMT uses.
