#### Discussion on Warren Tannery Park & Heritage Trail Proposal.

**DISCUSSION:** Teresa Whalen state that last month the committee came to the town board to request that they could use the existing grass Trail as the Trail to the proposed park and also requested to have someone who is insured & licensed to cut down some trees to have more view of the river. She stated that in the 90's there were grants that were applied for to have 7 Pocket Parks along the river. After review from the State the grants were not approved for funding. In 2002 Warren County Planning resubmitted the grant and were approved funding for 4(four) of the parks.

**Supervisor Kevin Geraghty** stated the APA and DEC need to be contacted and supply the town with a letter of approval on what can be done along the river. Kevin, also requested that the town Attorney review the proposal first and if this is going to involve more work for the Parks and Rec Dept. this needs to be reviewed and discussed as well.

**Jim Hull** stated that when they did this Hamlet expansion they put a lot of hours into that work and what the APA tells in front of you may completely change when you send in the application and when they have their enforcement Authority review the area.
