DISCUSSION: Supervisor Geraghty asked Andrew to explain this Grant.

Andrew Alberti from Flatley Reed, Inc. Stated, Under the direction of the EDC they have been requested to apply for a NYS Main Street Target area Renovations Grant in the amount of \$300,000. This Grant is funded to businesses commercial as well as commercial mixed use buildings to assist with renovations. Typically, this is a \$50,000 per building with a \$25,000 kicker up to \$100,000 total this would be paid out by the business owner or building owner and then would be reimbursable to them. The municipal outlay is nothing.

RESOLUTION TO APPROVE SETTLEMENT AGREEMENT WITH ASH REAL ESTATE HOLDINGS, LLC

WHEREAS, Ash Real Estate Holdings, LLC (Defendant) owns Property located at 100 River Street in the Town of Warrensburg identified a Tax Map Parcel Number 211.17-1-7 (the Property) which was damaged by fire on November 29, 2020; and

WHEREAS Defendant failed to remediate its Property and the Town commenced litigation in Warren County Supreme Court under Index Number EF2022-70090; and

WHEREAS, Defendant has, since the commencement of this litigation begun remediating his Property by demolishing portions of the structure damaged by fire, putting up a safety fence, commissioning engineered stamped designs for the rebuild, obtaining a Local Land Use Development Permit from the Town and has applied for a County Building Permit; and

WHEREAS, Defendant needs time to construct the building contained in the application for a County Building Permit, and

WHEREAS, the Parties wish to avoid any further litigation costs while Defendant remediates its Property.

NOW, THEREFORE, BE IT

RESOLVED, that the Town Board agrees to settle the litigation upon terms which would allow Defendant until September 30, 2024 to substantially complete the project (i.e. obtain "dried in" status) at the Property and if Defendant fails to do so or fails to be granted an extension by the Court for good cause shown, Defendant would not object to an Order from the court finding the Property to be in violation of the Warrensburg Town Code and State Code and would agree to an Order allowing the Town the right but not the obligation to demolish or remediate the Property at Defendant's sole cost which will include attorneys' fees and any other professional service costs associated with this violation and such expenses will become a lien on the Property and will be added to the Property's Town tax bill to be collected with the payment of Town taxes; and

BE IT FURTHER

RESOLVED, that the Town Supervisor of Deputy Supervisor is authorized and directed to sign a Settlement Agreement between the Town and Defendant in a form as it is attached to this Resolution; and

BE IT FURTHER

RESOLVED, that the Town Supervisor, Town Clerk and Town Counsel are hereby authorized and directed to take all actions necessary to effectuate the intent of this Resolution.
