Councilman Barlow said it is now up to the Town Clerk to bill Mr. Emrick for that amount, he has advised her that he polled the Board for a time frame for the payment of that, it is not necessary the Board pass any resolutions considering this. Radner (Town Attorney) about the situation and any filing fees after the satisfaction of the judgment are up to Mr. Emrick to pay back, if he wants to get a clear title and get the lien off from his property.

Councilman Markey asked if the Town Board was authorizing sixty days to pay if the lien is already filed. Town Clerk Combs said the paperwork for the lien is filed; it has been filed since July of 2008. Town Clerk Combs said she now needs to determine how many days to give Mr. Emrick to pay the bill he owes the Town, and, if he does not make that bill payment that amount will become the actual lien. Town Clerk Combs said she had asked that his attorney have him be the responsible party to pay the legal fees involved to remove the lien, if when meets the requirement.

Discussion ensued on when the fines stopped, if the project was completed on the outside, the fact that Mr. Emrick agreed to the original agreement arrangements with the Zoning Board of Appeals, and the fact the Zoning Office has removed the violations, and the repercussions on what will occur if the fines are not paid.

The Town Board agreed on the 60 day time limit for payment of the fine.
