DISCUSSION – BROWNFIELD PROJECTS

Supervisor Geraghty opened discussion reporting there had been a meeting on the Brownfield Projects, the action plan for the Board and Paper Brownfield Project from the State of New York is on file in the Town Clerk's Office. Supervisor Geraghty explained the State is saying the project is finalized and does not need any more remediation, the Town hopes to get a letter from the State signing off which says the property can be used for anything, if the Town gets the letter from the State the Town will take ownership of

the property. Supervisor Geraghty said that project came in well under the \$380,000.00 budgeted.

Supervisor Geraghty said the Town is receiving comments from some of the neighbors, he does think the neighbors have received the report and they, as well as the Town, are concerned about the landscaping of the site now. Supervisor Geraghty said it is his hope since the project did come in so far under budget that the Town will take that action.

Supervisor Geraghty reported the Town will be done with the Econoquick site on Richards Avenue by the end of this year, as well, if we get the same bill of health as we got for the other site it is his belief this can be used for commercial development.

Mr. Parisi told the Town Board the museum will be free admission but they will solicit donations like every other museum and the library, by next year they should be able to finance a lot of what it needs.
