

**SPECIAL MEETING, WARRENSBURG TOWN BOARD,
AUGUST 15, 2012**

A special meeting of the Warrensburg Town Board was held on Wednesday, August 15, 2012 at the Albert Emerson Town Hall at 4:30 p.m. with the following members present:

DISCUSSION – VENDOR RULES

Supervisor Geraghty asked Chris Belden to explain what the meeting was about.

Mr. Belden told the Town Board that earlier in the year he had talked about creating a list of rules for people coming in to get the IPP permit. Mr. Belden said if they have received the rules right up front, then when he goes out to check the permits people are not oblivious to those rules. Mr. Belden told the town board that he had spoken to Kathy about giving out the rules because Donna (the Town Clerk) was on vacation and that Kathy explained that Donna would like a town board resolution made to attach these rules to the permits.

Councilwoman Marcella asked what the rules meant for vendor parking in regards to on the street parking.

Discussion ensued on parking during garage sale, trouble spots where streets are blocked and congested that the Town is aware of and ways and suggestions on how the town might deal with those problems.

Supervisor Geraghty will tell DOT that the Town of Warrensburg will be posting signs on both ends of the town stating no RV parking and have them make signs up.

Discussion ensued on Bruce Park. Supervisor Geraghty told the Town Board he was concerned with people parking there and wished to make that off limits for parking. Supervisor Geraghty

said he did not want the damage up there, and, asked if anyone tracks who parks there.

Discussion ensued on where the RV's could park with several suggestions be given including the Warrensburg Fire Department, Hometown Oil, the County Fair Grounds.

Mr. Belden told the Town Board he was going to add to the list of rules that the IPP permit needs to be properly displayed.

Discussion ensued on Second Avenue being shut off and the area in front. Supervisor discussed the no parking there and said they are going to enforce that this year.

Lynn Smith told the Town Board she thought the sheet of rules should be sent to property vendors.

Supervisor Geraghty said the town would send it to the major ones who rent their spaces, like the Episcopal Church. Supervisor Geraghty said the reason for doing this is for safety.
