Supervisor Geraghty discussed the new park the town will be developing and the discussion he had with the Town of Saranac Lake about the park they just opened. Supervisor Geraghty suggested the Town might consider a grant for something along the waters edge in the future. Supervisor Geraghty warned that if the Town does not change the Town will get lost; history is nice but you have to change and if you do not make changes to attract younger people who want to come into your community you will be left behind.

Teresa Whalen- told the Town Board Darlene Gregson has been very active in promoting our region and that she had expressed interest in the Town's Buy Local, Ms. Whalen suggested that Ms. Gregson partner with one of the local businesses to participate in the upcoming event because she lives in Schroon Lake.

Thomas Drane - spoke to the Town Board regarding the Board of Assessment Review and the whole Assessment process. Mr. Drane told the Town Board he had just gone through a kind of contentious assessment process regarding property that he is a member of an LLC on that is land locked.
