DISCUSSION - CHAMBER OF COMMERCE IN TOWN HALL Supervisor Geraghty said the Town has received a request from the Chamber of Commerce to re-locate their office to the basement of the Town Hall.

Attorney Hafner explained the Town can do this if the Town determines the space is surplus and is not needed for Town use, that it is for a fair contract amount and that it is being done for public interest. Attorney Hafner told the Town Board the lease resolution would be subject to permissive referendum.

Supervisor Geraghty said he would have the Chamber come in on the 28th of January and meet to find out exactly what the Chamber is looking for.

DISCUSSION - MODIFY RE-LEVIED WATER BILL

Supervisor Geraghty explained the circumstances for the Town Board's need to modify the property tax bill of Barbara Baker. Supervisor Geraghty said this lady had a leak, the Town spoke to her about it, she was under the impression that everything was fine, the town could not find the water leak because it was under the trailer. Supervisor Geraghty explained her next water bill was very high, there is a disconnect, she is elderly, the re-levy on her tax bill was astronomical and he has talked to her and the Town Board, the feeling of the Town Board was to reduce the water bill re-levy and have the County correct the bill. Supervisor Geraghty said from now on her bill will be sent to the son who lives out of state and the town has adopted a new policy to send a registered letter when they get a high reading on a meter and the property owner does not respond to the Town.
