NEW BUSINESS: Letter from the New York State Town Clerks Association noting that Donn Combs, Warrensburg Town Clerk has been voted by her peers as a District Director for the Association. As stated, "This is a distant and admirable honor bestowed only on a few clerks of the 932 towns throughout New York State". Congratulations Donna.

Glens Falls Transit has started Trolley service to the Town. Cost to the Town is \$1,000.

Amend Resolution request to purchase one 2018 Western Star 4700 SF Single Axle Dump Truck with Plow in amount of \$207,490.23 to \$211,469.23. Bid price from Onondaga County piggyback contract. The chassis specification has changed.

Resolution request in support of a New York State Office of Community Renewal "New York Main Street" Program application for 2017. The grant application is at no expense to the Town and is a follow up to our 2016 application. \$500,000 for Main Street which is a 75% to 25% matching Grant.

Discussion to be held on asking for 25' of no parking on the north side of Second Avenue from Main Street to the west. This is due to issues with parking and blocking the intersection for emergency vehicles.

We have been notified by the New York State Department of Transportation that State Route 418 will be paved this summer from River Street to the Town of Thurman. We have been discussing the poor condition of the road with DOT and they have responded positivity.

Request received to remove a street light from Hillcrest Drive by the current homeowner. We would like to relocate the light across from Curtis Park where some more lighting is needed.

Occupancy Tax request received from the Warrensburg Historical Society in the amount of \$548.00 for advertising expense.
