Supervisor Geraghty told the Town Board the Town has taken an ad again this year in the Southern Adirondack Magazine and that this year they have titled the ad Discover Warrensburg following Steve Parisi's lead with the Historical Society. Supervisor Geraghty said that Echo Lake Beach is included in the ad, and that the sign that said for Residents Only has been taken down.

DISCUSSION- SHORT TERM RENTALS

Councilperson Baker-Marcella asked if the Town Board was planning to do a public hearing on Short Term Rentals before they make any decisions.

Supervisor Geraghty said that we have to.

Councilperson Baker-Marcella said she wanted to make sure everybody has a chance to express themselves. Attorney Hafner explained that in order to pass a local law you have to have a public hearing. Attorney Hafner said sometimes Towns do have a public informational meeting about things in advance but that you do have to have a public hearing before you can pass a local law. Councilperson Baker-Marcella asked if the Town Board does not sometimes have the public hearing the same night that we pass the local law. Councilperson Baker-Marcella sid she was suggesting something separate, where everybody has a chance to speak.

Supervisor Geraghty said this is still a couple of months away.

DISCUSSION - BEACH

Councilperson Alexander opened discussion saying that he would like to make comment on the Beach being open to the public. Councilperson Alexander said that there were problems years ago with people renting the pavilion, they were not from Warrensburg and it got out of hand. Councilperson Alexander said we need to keep control over who rents the pavilion so our lifeguards don't have problems with people up there, everybody at the pavilion was sending their kids to the Beach and they were calling him to go be the constable. Councilperson Alexander said the Town needs to be cautious in renting the Pavilion to people who are not from here but are in Lake George.

Councilperson Baker-Marcella asked who over sees the Pavilion. Supervisor Geraghty said his office. Councilperson Alexander explained that people have to call in to reserve the Pavilion. Supervisor Geraghty said that a few years ago we had the Pavilion being rented out and we did not know who for who it was, we did but we did not know. Supervisor Geraghty said we had some unruly people coming from Lake George, we are not letting people from out of Warrensburg use that space but the Beach is open to the public.

On motion of Councilperson Alexander, seconded by Councilperson Rounds, the meeting was adjourned at 7:56 p.m.
