RE-CONVENE PUBLIC HEARING PROPOSED LOCAL LAW SHORT TERM VACATION RENTAL

Supervisor Geraghty declared the public hearing reconvened at 7:02 p.m.

Attorney Michael Borgos said that he had received the revised proposed local law today and that he had shared it with the property owners he has been representing here. Mr. Borgos said there were some general comments that he felt applied to all but that they each had their own specific comments that will apply; they are getting more towards factual comments for specific properties. Mr. Borgos said that he appreciated that the Town incorporated in 3D the provision to allow for prospective new owners to seek a permit ahead of time, in 4D #3 the Town adopted the notion of Warren County Department of Fire Prevention and Building Codes to conduct an assessment. Mr. Borgas said that he called there today and spoke with Charles about how he would implement that and Charles made him aware it will take him considerable time to get through a large volume of applications but seasonally this is a good time of year for him to get those, building permit applications are down. Mr. Borgas said Charles said that he can probably get everybody processed in thirty to forty days. Mr. Borgas told the Town Board the concern expressed last month was what would happen with the bookings already put under contract, they still need to talk about the start date of this local law.

Mr. Borgas told the Town Board the parking requirements is a consistent issue among all of the property owners that he has spoken with, he asked last month for a provision and a ratio of one parking space for every two permitted occupants was created. Mr. Borgas said he did not know if that was the right number, he looked in all of the Warrensburg Code for any other type of parking requirements based on usage or occupancy levels and he did not see any. Mr. Borgas said that he knew the Town had a hotel motel code provision, there is nothing in there that speaks to this.

The following persons spoke: Glenda Duell, Gary Cooper, Councilperson Baker-Marcella, Jim Hull, Councilperson Alexander, Councilperson Winslow and Sandra Parisi.

Supervisor Geraghty told everyone that the Town was not adopting any law tonight, he wanted to make that perfectly clear.

Discussion ensued on how many short term rentals there are in the Town of Warrensburg. Supervisor Geraghty said the Town had found forty.

Supervisor Geraghty asked Attorney White how the Board was to proceed, if they should schedule a public hearing for next month. Attorney White said it was up to the Board procedurally how they wanted to move forward and said there was quite a bit of revision since the last public hearing so she would recommend that if they wish to consider the revisions of the current version that they re-notice it for a public hearing. Attorney White told the Town Board they can wait and schedule a public hearing on the new document.

Supervisor Geraghty said they will close this public hearing and re-schedule a public hearing for the second week of January. The Supervisor asked if that worked for people so they can get this finalized by the March meeting.

All persons present who wished to be heard were heard.

The public hearing was closed at 8:05 p.m.
