WARRENSBURG TOWN BOARD May 8, 2019 REGULAR MEETING UNFINISHED BUSINESS:

I need permission to hire a surveyor to survey the beach property. We have found a survey map for the property.

The contract award for the WWTP Blower Building and Installation was awarded to MCJ Construction, LLC of Mayfield, N.Y. in the amount of \$185,000.

NEW BUSINESS:

Resolution to enter into a Shared Service Agreement between Warren County and the Town of Bolton, Town of Chestertown, City of Glens Falls, Town of Johnsburg, Town of Lake George, Village of Lake George, Town of Lake Luzerne, Town of Queensbury, Town of Stony Creek and Town of Thurman.

Resolution to allow Supervisor to attend the June Membership of the Adirondack Association of Towns and Villages in Saranac Lake on June 2 and June 3, 2019.

Warrensburg was award a \$911,424.00 under the NYSDOT Transportation Alternate Program (TAP) for River Street Sidewalk enhancement. Congratulations to Patty Monahan for her work on securing this grant. This is an 80% - 20% project.

Received notice that we will receive \$92,256.04 in CHIPS funding for 2019.
