Supervisor Geraghty said he did not know if this person ever got a letter, there is not a very good system in place right now, we don't know. Supervisor Geraghty asked the Town Clerk if Mr. Olson had ever received a letter and she said yes. Supervisor Geraghty told the Town Board he did not know if they wished to continue the practice of reduction and usage, everybody is given a one-time reduction. Supervisor Geraghty said that the Board needs to receive a list of high usage every time so when they get complaints. Supervisor Geraghty said that if the letter is not heeded when it is received, then it is not on the Town. Supervisor Geraghty said he did not think there was another Water Department around who does what we do to try to work with customers here.

Tracy Benoit said none of the ones he talked to do that.

Supervisor Geraghty said he was ok with that but that he would like to see a list of high usage sent to the Board. Supervisor Geraghty said he did not know if Mr. Olson had received a letter or not. Supervisor Geraghty said the Deputy Clerk's did not know if letters had been sent for the first billing or not.

Supervisor Geraghty said that he wanted the Board to get a copy of all of the letters that were sent out.

Supervisor Geraghty asked the Town Board if they wished to discontinue the high usage letters.

Councilperson Baker-Marcella said that if people do not know it is running and high usage it is responsible and courteous of them to let them know, then if they do not respond it is another issue.
