**Peggy Knowles** – asked if the shrubs along the parking of Tops Market could be trimmed, it is hard to see traffic when pulling out. They were trimmed by Parks & Rec. recently but with all the rain they are growing fast. **Kevin** said they would have them trimmed again.

Linda Marcella – Asked a few questions about the sludge removal project and about Main Street Beautification awards that were done a few years ago and how this incentive might help the Curb Appeal of Main Street. Linda also wanted to thank the board for the decision of making "Blister Hill" Parkland. Linda asked for approval and help from the town in cleaning up the trails on Hackensack Mt.
